If you want to find the cutting edge of new plant varieties, marketing and merchandising ideas, the California Pack Trials are the place to be. With 23 separate locations and more than 30 companies, you'll need to do some careful itinerary planning. Appointments are required at some locations and recommended everywhere else.

A few changes to take note of this year:

1. Ball Horticultural Co., has folded its trials into a one-stop, all-inclusive trial with both seed and vegetative genetics at their PanAmerican Seed facility. One less stop, but plan on spending more in Santa Paula.

2. You'll still find Fischer's vegetative genetics at Goldsmith Seeds this year, but they'll be under the Syngenta Flowers umbrella (due to Syngenta acquiring Fischer). You'll find the seed genetics and perennials for the Syngenta group at the S&G Breeding facility.

3. K. Sahin Zaden B.V. has changed location from Greenheart Farms to American Takii due to Takii Japan acquiring the company.
