Updates on the New H-2A Rule

Rep. Kelly Armstrong (R-ND), Rep. Cliff Bentz (R-OR-02), Rep. Dusty Johnson (R-SD), Rep. Bill Huizenga (R-MI-04) and Rep. John Moolenaar (R-MI-02) introduced H. J. Res. 134, providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Department of Labor, relating to "Improving Protections for Workers in Temporary Agricultural Employment in the United States."

This Resolution would utilize the Congressional Review Act to reverse the Department of Labor's April 29 rule governing the certification of temporary, nonimmigrant workers on H-2A visas. The DOL announced a final rule that places more regulatory burdens upon farmers, ranchers, producers and growers. AmericanHort is supportive of this effort to assist with the new H-2A Rule.

In April, the DOL announced a final rule to strengthen protections for farmworkers. It targets vulnerability and abuses experienced by workers under the H-2A program that undermine fair labor standards for all farm-workers in the U.S. The rule increases and strengthens worker protections, enhances the Department's enforcement capabilities in the H-2A temporary agricultural employ-ment program, and helps to ensure that an employer's use of the H-2A program does not adversely affect the wages and working conditions of workers in the U.S.

The final rule will take effect on June 28, 2024. For more information, GO HERE.

AmericanHort Helps Drive Congressional Support for Increased Funding for the IR-4 Project

In a bipartisan effort to support research for specialty crop growers, Rep. Lori Chavez-Deremer (R-OR-05) and Rep. Jimmy Panetta (D-CA-19) spearheaded a Dear Colleague letter to appropriators encouraging them to increase funding to the authorized level for the IR-4 Project for fiscal year 2025.

Authorized at \$25 million, the IR-4 project was funded at \$15 million each year for fiscal years 2023 and 2024. The IR-4 Project holds paramount importance for AmericanHort and our members as it serves as a pivotal bridge between scientific advancements and the practical needs of growers, ensuring the availability of safe and effective pest management tools for horticultural crops. Further, the project focuses on facilitating the registration of pest control products for specialty crop production, including biological pest control agents and biochemicals that play an important role in implementing Integrated Pest Management (IPM), and for nursery and greenhouse producers to maintain progress consistent with major crop producers.

With encouragement from AmericanHort, this letter had bipartisan support from eight Republicans and 23 Democrats. AmericanHort will continue to push for increased funding for this vital program.
